All artist should take theme of the show Faces & Places into consideration when selecting their entries.

When submitting your artwork for this show, please take into consideration the large number of children that pass through the gallery. Explicit nudity is not permissible, and the Slidell Art League reserves the right to decline any piece deemed unacceptable to the general public.

Art work must have been completed after March 1, 2007 & not previously exhibited in a judged Slidell Art League show.

2-D Pieces - must not exceed 48" on any one side. Overall weight can not exceed 90 lbs. **All artwork must be framed and ready to hang with screw and wire only. Entries without suitable wire securely attached will be declined.** Positively NO saw tooth hangers will be accepted. Gallery wrapped canvas are acceptable provided they are suitably finished with no exposed staples or other hardware.

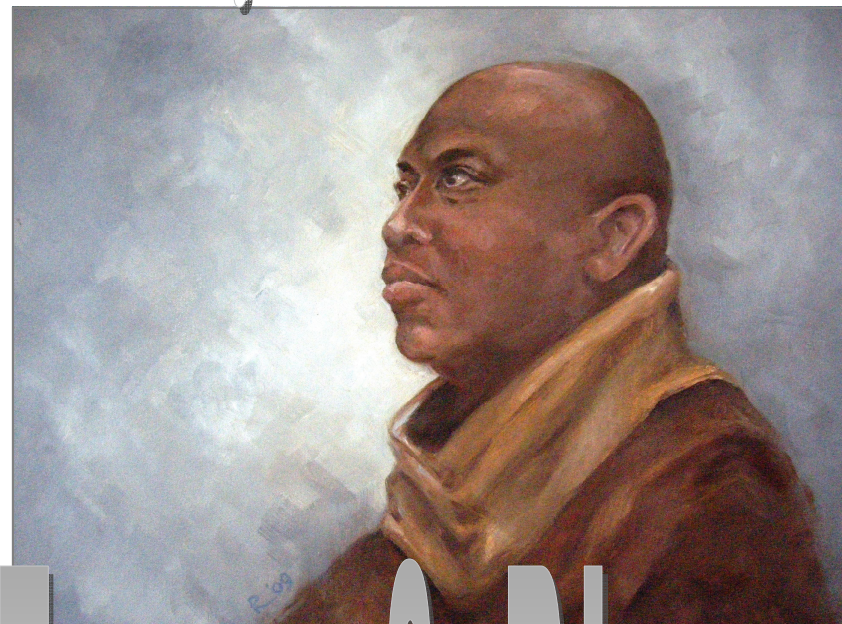
3-D Pieces any assembly of pieces must be handled by the artist.
